- Secure SSH access must be provided through out the hosting tenure, cost will be included in the quotation itself i.e. no extra cost shall be levied for this other than the consolidated quotation provided for the hosting services.
- Hosting must ensure reliable uptime suitable for an institutional website.

7. Support & Service:

- Technical support for VPS-related issues.
- Support through email / phone / ticketing system.
- Timely resolution of server-related problems.

8. Commercial Requirements:

- Quoted rates shall be inclusive of all charges except GST.
- GST must be quoted separately as applicable.
- No hidden or additional charges will be entertained later.
